**AN ORDINANCE PROHIBITING CHILDREN BELOW FIFTEEN (15) YEARS OF AGE IN SENDING AND/OR ALLOWING THEM TO BUY INTOXICATING BEVERAGES, CIGARETTES FOR THEIR OWN CONSUMPTION AND PROVIDING PENALTIES THEREOF.**

**WHEREAS**, children below 15 years of age are sometimes sent or allowed by their parents, guardians and relatives to buy intoxicating beverages and cigarettes for their own sake;

**WHEREAS**, children in their young age buying from stores and alike of the above stated items are not aware of the physical effects of such to their health and well-being as a whole;

**WHEREAS**, parents, guardians and relatives of these minors shall strictly be prohibited in sending and/or allowing them to buy intoxicating beverages and cigarettes from any stores for their own consumption and shall be held liable for their actions;

**NOW THEREFORE**, BE IT ENACTED BY THE SANGGUNIANG BARANGAY OF OSMEÑA, PROVINCE OF NUEVA VIZCAYA, UPON MOTION BY **HONORABLE CESAR M. DAGUIO** DULY SECONDED BY THE BODY WITHOUT ANY OPPOSING VOTE, BY VIRTUE OF THE POWERS VESTED BY R.A. 7160, IN SESSION ASSEMBLED, THAT:

**Section 1. TITLE.** This ordinance shall otherwise be known as the Barangay Osmeña Protection of Children Under 15 Years of Age from Intoxicating Beverages and Cigarettes Ordinance.

**Section 2. DEFINITION OF TERMS.** As use in this ordinance, the following terms shall mean:

- (a) Intoxicating Beverages - alcoholic drinks liable to cause someone to lose control of their faculties or behaviour.
- (b) Cigarettes - a thin cylinder of finely cut tobacco rolled in paper for smoking.
- (c) Child/Minor - a young human being below the age of puberty or below the legal age of majority.
- (d) Parents - a father or mother.
- (e) Guardian - is a person who has the legal authority (and the corresponding duty) to care for the personal and property interests of another person.
- (f) Penalty - a punishment imposed for breaking a law, rule, or contract.
- (g) Store - a retail establishment selling items to the public.

**Section 3. PENALTY.** Any person who shall violate, disobey, refuse and/or neglect to comply with any of the provision of this ordinance shall be punished in accordance with the following penalty:

- 1<sup>st</sup> Offense – ₱500.00 – Parents, guardians, relatives and store owners
- 2<sup>nd</sup> Offense – ₱700.00 - Parents, guardians, relatives and store owners
- 3<sup>rd</sup> Offense – ₱1,000.00 - Parents, guardians, relatives and store owners

**Section 4. COLLECTION AND DISPOSITION OF FINES.** The payment of fines for violation of this Ordinance shall be paid to the Barangay Treasurer and shall accrue in favor of the Barangay Council for the Protection of Children's (BCPC) fund.

**Section 5. REPEALING CLAUSE.** All Ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

**Section 6. SEPARABILITY CLAUSE.** All Barangay Ordinances, Rules and Regulations, or other parts thereof, in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

**Section 5. EFFECTIVITY.** This Ordinance shall take effect after 30 days.

**WHEREFORE,** on motion of Hon. Cesar M. Daguio and duly seconded by the body, it was;

Enacted on this 22 day of OCT, 2016, Barangay Osmeña, Solano, Nueva Vizcaya.


