**AN ORDINANCE AMENDING THE OMNIBUS BARANGAY TAX ORDINANCE NO. 2005-01 ENTITLED "IMPOSING FEES FOR THE ISSUANCE OF A BARANGAY CLEARANCE, CERTIFICATION AND OTHER REGULATORY FEES."**

**BE IT ENACTED** by the Sangguniang Barangay of Osmeña, Solano, Nueva Vizcaya, that:

**ARTICLE I. GENERAL PROVISION**

1. **TITLE.** This ordinance shall be called the Barangay Tax Ordinance of 2005-01 of Barangay Osmeña, Solano, Nueva Vizcaya.

2. **SCOPE.** This ordinance shall govern the levy, assessment and collection taxes, fees, charges by the barangay as provided for by the Local Government Code of 1991 (Section 129, 130, 152 and 153).

**ARTICLE II. TAXES, FEES AND CHARGES**

**Section 1. Service fees or charges for services rendered**  
**Garbage Collection**

- Households – Php40.00/month
- Business Establishments – Php50.00/month
- Special Waste – Php150.00/month
- Resort – Php200.00/month

Section 4. TIME OF PAYMENT. The fees imposed herein shall be paid to the Barangay treasurer upon filing the application or before the issuance of the Clearances or Certifications applied for.

Section 5. ADMINISTRATIVE PROVISION. Issuance of Barangay Clearance for any business or trade activity located or conducted within the territorial jurisdiction of Barangay Osmeña as a requirement before the Mayor issues a license or permit, shall be acted upon within seven (7) working days from the filing thereof. In the event that a clearance is not issued within the said period, the Mayor may then issue a corresponding license or permit being applied for by the applicant.

Section 6. PENALTY. Violation of any provision of this Ordinance shall be punished by a fine of not less than One Hundred Pesos (Php100.00) but not more than One Thousand Pesos (Php1,000.00).


Section 7. SEPARABILITY CLAUSE. If any provision of the Omnibus Tax Ordinance is declared unconstitutional or invalid, such sections or parts not affected thereby shall remain in full force and effect.

Section 8. REPEALING CLAUSE. All Barangay Ordinances, Rules and Regulations, or other parts thereof, in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


Section 10. EFFECTIVITY. This Ordinance shall take effect upon the date of its approval.






