AN ORDINANCE ESTABLISHING AN ECOLOGICAL SOLID WASTE MANAGEMENT FOR BARANGAY OSMEÑA, SOLANO, NUEVA VIZCAYA PROVIDING PENALTIES FOR VIOLATION AND THEREOF FOR OTHER PURPOSES.

BE IT ENACTED by the Sangguniang Barangay of Osmeña, Solano, Nueva Vizcaya, that:

Section 1. This barangay is adopting the Municipal Ordinance No. 2007-01 establishing an Ecological Solid Waste Management appropriating funds thereof, prescribing fees for services related thereto, providing penalties for violation thereof and for other purposes;

Section 2. To enhance the implementation by adopting its provisions beyond the limit and control under the jurisdiction of the barangay;

Section 3. The Chairman of the Barangay Ecological Solid Waste Management Committee, together with its Co-Chairman and members shall be responsible to spearhead the same.

Section 7. ***Effectivity.*** This Ordinance shall take effect after the date of its approval.




