BARANGAY ORDINANCE NO. 08
Series of 2014

AN ORDINANCE REQUIRING EVERY HOUSEHOLD, BOARDERS OF APARTMENT/BOARDING HOUSE, BUSINESS ESTABLISHMENTS, SCHOOLS AND PUBLIC PARKING AREA, TODA AT BARANGAY OSMEÑA, SOLANO, NUEVA VIZCAYA TO PUT-UP GARBAGE BINS/RECEPTACLES IN THEIR RESPECTIVE PREMISE/VICINITY SERVES AS TEMPORARY CONTAINMENT OF SOLID WASTE MATERIALS AND SHALL PROVIDE A COMPOST PIT AS WASTE DIVERSION FOR COMPOSTABLES THEREOF.

WHEREAS, the Barangay Ecological Solid Waste Management Committee is created in consonance to Section 10 of Republic Act 9003 through the issuance of Memorandum Circular 2001-38 emphasizing the vital role of the barangay in successful implementation of the program particularly in the segregation, collection and recycling of waste at source;

WHEREAS, all households, business establishments and public parking areas in the barangay are required to have a garbage bins/receptacles in their respective premises/vicinities wherein the solid waste materials are placed;

WHEREAS, the solid waste materials should be segregated at source according to the kinds such as compostable, recyclables, residuals and special/hazardous in the said garbage bins/receptacles;

WHEREAS, the solid waste materials will be brought out only in respective premises/vicinities on the day of scheduled collection by the garbage truck according to what kind of materials to be collected for that day only;


WHEREAS, the scheduled day for the collection of residuals (Plastic, sachet, food wrappers, etc.) is on every Thursday and Friday of the week and Saturday for the compostable materials (garden waste, leaves, etc.) and thereafter;

WHEREFORE, on motion of Hon. Evangeline M. Hernaez and duly seconded by the body, it was;


RESOLVED, AS IT IS HEREBY RESOLVED, TO REQUIRE EVERY HOUSEHOLD, BOARDERS OF APARTMENT/BOARDING HOUSE, BUSINESS ESTABLISHMENTS, SCHOOLS AND PUBLIC PARKING AREA (TODA) AT BARANGAY OSMEÑA, SOLANO, NUEVA VIZCAYA TO PUT-UP GARBAGE BINS/RECEPTACLES IN THEIR RESPECTIVE PREMISE/VICINITY SERVES AS TEMPORARY CONTAINMENT OF SOLID WASTE MATERIALS AND SHALL PROVIDE A COMPOST PIT AS WASTE DIVERSION FOR COMPOSTABLES THEREOF.
