BARANGAY ORDINANCE NO. 10

AN ORDINANCE ESTABLISHING THE PERMANENCE OF MOOE FOR THE BARANGAY OSMEÑA EDUCATIONAL ASSISTANCE FOR THE SCHOLARSHIP OF INDIGENT CHILDREN (SEAP/ALS) TO BE ONE HUNDRED THOUSAND PESOS (P100,000.00) PER ANNUM.

BE IT ENACTED by the Sangguniang Barangay of Osmeña, Solano, Nueva Vizcaya, that:

Section 1. The barangay MOOE fund was allocated for various committee programs/projects in the barangay;

Section 2. The allotted MOOE for the Barangay Educational Assistance for Scholarship of Indigent Children (SEAP/ALS) is One Hundred Thousand Pesos (P100,000.00);

Section 3. The Sangguniang Barangay decided to make the amount allotted for the MOOE of Barangay Educational Assistance for Scholarship of Indigent Children (SEAP/ALS) to be permanent for the years to come;

Section 4. The permanence of the MOOE budget for the Barangay Educational Assistance for Scholarship of Indigent Children (SEAP/ALS) will secure the said amount and will give an assurance for future scholars to be helped by the barangay;

Section 6. Repealing Clause. All Ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

Section 7. Separability Clause. All Barangay Ordinances, Rules and Regulations, or other parts thereof, in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 8. Effectivity. This Ordinance shall take effect after 30 days.






