BARANGAY ORDINANCE NO. 04
Series of 2014

AN ORDINANCE REQUIRING ALL OWNERS OF APARTMENTS, BOARDING HOUSES AND/OR ITS SIMILAR KIND OF BUSINESS TO SECURE BUSINESS CLEARANCE AND TO REGISTER ALL THEIR OCCUPANTS TO INCLUDE THE NAMES, POSTAL ADDRESSES IN THE BARANGAY.

BE IT ENACTED by the Sangguniang Barangay of Osmeña, Solano, Nueva Vizcaya, that:

Section 1. All owners of apartment/boarding house located in the barangay are compulsory required and shall secure necessary business clearance prior to its operation;

Section 2. Any person engaged in this kind of business without necessary papers to operate will be deemed illegitimate of operation and be penalized under the Barangay tax Ordinance on its corresponding payment;

Section 3. The owner of the apartment/boarding house shall register the names, postal addresses (place of birth) of their boarders/occupants (old and new) to the barangay for accounting, identification and other legal purposes.

Section 4. **Penalty.** Violation of any provisions of this Ordinance shall be punished by a fine of Three Hundred Pesos (Php300.00) First Offense – non registration of business for the current year, Five Hundred Pesos (Php500.00) Second Offense – non registration of business for the following year and One Thousand Pesos (Php1,000.00) Third Offense – non registration of business for the third year.


Section 5. **Repealing Clause.** All Ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

Section 6. **Separability Clause.** All Barangay Ordinances, Rules and Regulations, or other parts thereof, in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


Section 7. **Effectivity.** This Ordinance shall take effect after thirty (30) days from the date of its approval.
