BARANGAY ORDINANCE NO. 03

Series of 2014

AN ORDINANCE ADOPTING THE MUNICIPAL ORDINANCE BO. 99 – 015 OF SOLANO, NUEVA VIZCAYA PRESCRIBING SANITARY MEASURES FOR OWNERS OF BACKYARD PIGGERIES AND PENALTIES, PIGGERY FARMS, POULTRY FARMS IN THIS BARANGAY AND PROVIDING CORRESPONDING PENALTY THEREOF.

Section 1. Chapter I, General Information, Powers, Duties and Functions of the Sangguniang Barangay as the legislative bodies of this barangay, shall enact ordinances, approve resolutions and appropriate fund for the general welfare of the barangay and its inhabitants;

Section 2. The Sangguniang Barangay exercise such other powers and perform such other duties and functions implementing Ordinances and Resolutions;

Section 3. The Sangguniang Barangay may see to it that the improvements of the barangay or for the welfare of the inhabitants thereof;

Section 4. To enhance on its implementation by adopting its provisions beyond the limit and control under the jurisdiction of the barangay;

Section 5. **Repealing Clause.** All Ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

Section 6. **Separability Clause.** All Barangay Ordinances, Rules and Regulations, or other parts thereof, in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.

Section 7. **Effectivity.** This Ordinance shall take effect after thirty (30) days from the date of its approval.
