BARANGAY ORDINANCE NO. 05

AN ORDINANCE ENJOINING ALL HOUSEHOLD OWNERS TO RENDER ONE (1) DAY COMMUNITY SERVICE PER MONTH IN THE BARANGAY PURPOSELY IN MAINTAINING CLEANLINESS IN THEIR RESPECTIVE PREMISES AND OUTSIDE THEIR RESIDENCE.

BE IT ENACTED by the Sangguniang Barangay of Osmeña, Solano, Nueva Vizcaya, that:

Section 1. The household owners are obliged to render one (1) day Community Service in cleaning their premises and/or maintaining its cleanliness to include the shoulder of the road adjacent to their lots;

Section 2. Vacant lot/abandoned area with or without building erected and/or found uninhabited place/area, thus, the legal owner is responsible in maintaining its cleanliness and other adjacent place where the lot is located;

Section 3. A participation governance of the barangay is fully observed and implemented in this kind of activity as one of the goals and objectives in lieu with the existing rules and regulations of the municipal/barangay ordinance on Ecological Solid Waste Management;

Section 4. As leaders in the community, all members of the barangay council/employees, Barangay Tanods, BNS/BHWs, 4Ps, GOs, POs, NGOs and civic organizations are hereby enjoined for the purpose and as part in the delivery of basic services in the community.

Section 5. The Community Service Day shall be held every third week, Saturday of the month as agreed by the Sangguniang Barangay members and the community as a whole.

Section 6. **Repealing Clause.** All Ordinances, rules and regulations, or parts thereof, whose provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

Section 7. **Separability Clause.** All Barangay Ordinances, Rules and Regulations, or other parts thereof, in conflict with or contrary to the provisions of this Ordinance are hereby repealed, amended or modified accordingly.


Section 8. **Effectivity.** This Ordinance shall take effect upon the date of its approval.
